BENEFITS OF THE CORPORATE PARTNER PROGRAM

Dedicated AABB Account Executive: Contact information to be provided within five (5) business days of Application and Agreement execution.

Individual AABB memberships: Up to four individual AABB memberships, which shall be co-termed with the Term of this Application and Agreement individual memberships are assigned at the discretion of the Corporate Partner and shall be effective for the term of this agreement. One of the four memberships will be provided to the Primary Contact listed on this Application and Agreement.

Use of AABB Corporate Partner logo: In accordance with the AABB Logo Usage Guidelines.

Yearly meeting with AABB Board of Directors: Up to three (3) participants invited to meet exclusively in person with the AABB Board of Directors and executive team, to discuss leading issues and topics affecting the industry and your business.

Access to Ask-an-AABB Expert: Inquiries for expert guidance (e.g., Standards, Regulatory, etc. provided by AABB staff) will be provided via email, video or phone call, or in-person meeting. Such inquiries shall be submitted to the dedicated AABB Account Executive. Inquiries shall not exceed two per month per Corporate Partner or a staff time commitment not to exceed one hour per month. TERMS AND CONDITIONS OF THE CORPORATE PARTNER PROGRAM

Participants in the Corporate Partner Program shall be invoiced upon execution of this Application and Agreement and partner benefits shall commence at that time. The invoice shall be due upon receipt. Benefits including the individual memberships shall continue for one year and will automatically renew each year unless terminated by either party. A 30-day notice is required for termination of agreement. Individual memberships are assigned at the discretion of the Corporate Partner and shall be effective for the term of this agreement.

AABB shall use all reasonable means to fulfill the benefits of the Corporate Partner program. In the event that activities are canceled (e.g., in the instance of a virtual Annual Meeting), AABB reserves the right to cancel such events in its sole discretion. No pro rata refund of annual Corporate Partner fees will be provided.
