# **Branding Guidelines & Logo Usage**

AABB-Accredited facilities recognized with the Cellular Starting Material (CSM) Qualification are invited to use the "AABB CSM-Qualified Facility" logo to promote their accreditation status and to highlight their expertise, capacity and practices related to collecting CSM. Only AABB-Accredited facilities that have been recognized as CSM-Qualified by AABB may refer to themselves as a "CSM-Qualified Facility." The logo may only be used by AABB-Accredited facilities in good standing, and may not be used by facilities or organizations that are not currently recognized with the CSM Qualification.

### LOGO USAGE

The "AABB-CSM Qualified Facility" logo must be used in its original format, color, and aspect. The logo may not be modified or distorted.

Allow an area of isolation– based on the height the lowercase letters (X)– around the logo (A). When sizing, reduce or enlarge the graphic staying true to original proportions. Do not add or apply other graphical treatment to the logos.

### Logo Style Formats

The logo is provided in two file formats: EPS and PNG. In addition, two style formats are provided: seal and logo (B), stacked seal and logo (C), and seal only (D).

Select the appropriate format based on the design application and available space.

### **Logo Color Applications**

The logo should be used in the AABB brand colors whenever possible. In instances where this is not possible, it is acceptable to use the reverse (E), white (F) or grayscale (G) version.


