1. Solicit concerns from institutional and individual members and committee chairs to be discussed with the FDA. Maintain confidentiality.
  2. Prepare topics for discussion with FDA. Work with Regulatory and Communications staff to communicate outcomes of discussions to the membership and other committees as appropriate.
  3. Develop and periodically update a list of topics/issues that can be represented by other AABB members in FDA's public forums as a means of further establishing the AABB's presence and having AABB positions on key issues entered into the public record.
  4. Serve as a resource for the Director of Regulatory Affairs in developing position statements and identifying speakers to represent the AABB at FDA meetings.
